The London & Middlesex Housing Corporation is a nonprofit corporation that provides subsidized housing for the City of London and the County of Middlesex.

We are the largest provider of rent-geared-to-income housing in the London-Middlesex area. We have apartments for adults and seniors in London, Strathroy, Dorchester, Newbury, Parkhill, and Glencoe.

We also offer townhouses for families in London, Strathroy, and Newbury. We **do not** provide temporary or emergency housing (see “Other Housing Options”).

How do I apply for housing?
You should call or go to the **Housing Access Centre (HAC)**, located at:

They will give you an application form for rent-geared-to-income housing. Fill out the form, and also give the Housing Access Centre the income documentation that they request.

Housing is **not** offered on a first-come-first-served basis.

Applicants are responsible for updating the information on their applications regarding income, change of address, telephone numbers or family circumstances.

This is very important, because a change in information could change your place on the waiting list.

Who is eligible to apply for rent-geared-to-income housing?

To apply for rent-geared-to-income housing you must be:

- 16 years of age or over and
- A Canadian Citizen or
- A Landed Immigrant or
- A Refugee who is legally allowed to live in Canada



What will I need for my application?

You may need:

- Birth certificate
- Proof of **all** income
- Shelter cost receipts
- Social Insurance card
- Mortgage agreement
- Immigration status papers
- Custody papers
- Bank books (up-to-date)
- Insurance policies
- Hydro and fuel bills
- Bank/Credit Union statements

Other papers may also be requested.

What choices do I have?

LMHC apartment buildings for adults and seniors have bachelor and one bedroom apartments. These apartments include a stove and a refrigerator. Coin-operated laundry facilities are available in these buildings. We also have one bedroom wheelchair accessible apartments in some buildings.

Townhouses and semi-detached homes for families have two, three, four and five bedrooms. These homes **do not** include a stove, refrigerator or laundry equipment.

London & Middlesex Housing Corporation also administrates the **Rent Supplement Program.**



Appeal Process

If your application for rent-geared-to-income housing is denied, you may appeal this decision. You will be notified in writing by HAC of the denial, and you can ask for an Appeal Form.
